Our approval is based on Clause 19.1(a) of the Terms and Conditions and is supported by certain of the Holders, which together in total represents 62.20 per cent. of the Total Nominal Amount (the "Instructing Holders").

The Instructing Holders has confirmed that they do not deem that the Event of Default is detrimental to the Holders and will not instruct the Agent to accelerate the Bonds as a result of the Event of Default.

The waiver is conditional upon that the Instructing Holders agree not to sell their bonds until the Expiry Date (as defined below) and that the Instructing Holders undertake to unconditionally participate and vote No in case any Holders convene a bondholders' meeting or written procedure where it is proposed to accelerate and/or enforce any security pursuant to the covenant breach covered by the waiver.

All capitalised terms used herein and not otherwise defined in this notice shall have the meanings assigned to them in the Terms and Conditions.

The Issuer has confirmed to the Agent that the Issuer has failed to fulfil its obligations under Clauses 1.1 and 13.6 (*Maintenance Test*) for the third quarter 2019. According to item (ii) of paragraph (c), the utilised capacity of the Wind Turbines expressed as a percentage of the seasonality-adjusted Total Capacity for the Financial Quarter (for Q3, 22 per cent. of annual Total Capacity) must be equal or higher than 75 per cent. According to the Issuer's reporting, the utilised capacity for the quarter was 70 per cent.

In our capacity as Agent, we hereby notify the Holders, in accordance with Clause 14.6 of the Terms and Conditions, that an Event of Default under Clauses 1.1 and 13.6 (*Maintenance Test*) of the Terms and Conditions has occurred and is continuing.

The Agent has been informed by the Company that the three largest Holders are of the view that the Event of Default is not detrimental to the Holders and that they intend to send an instruction to the Agent in which this is stated and furthermore that they do not intend to instruct the Agent to accelerate the Bonds and will, based on this, request the Agent to waive the Event of Default without initiating a Written Procedure with respect to the Bonds.
